

Revenue Effects of Major Tax Bills Updated Tables for all 2012 Bills

Since 1940 many major tax bills have been enacted. OTA Working Paper 81 (Revised September 2006) uses revenue estimates of each bill to create consistent measures of the relative size of the several dozen major tax bill enacted between 1940 and 2006. This document updates the tables through 2012. Further information about the methodology used in the tables can be found in the working paper.
